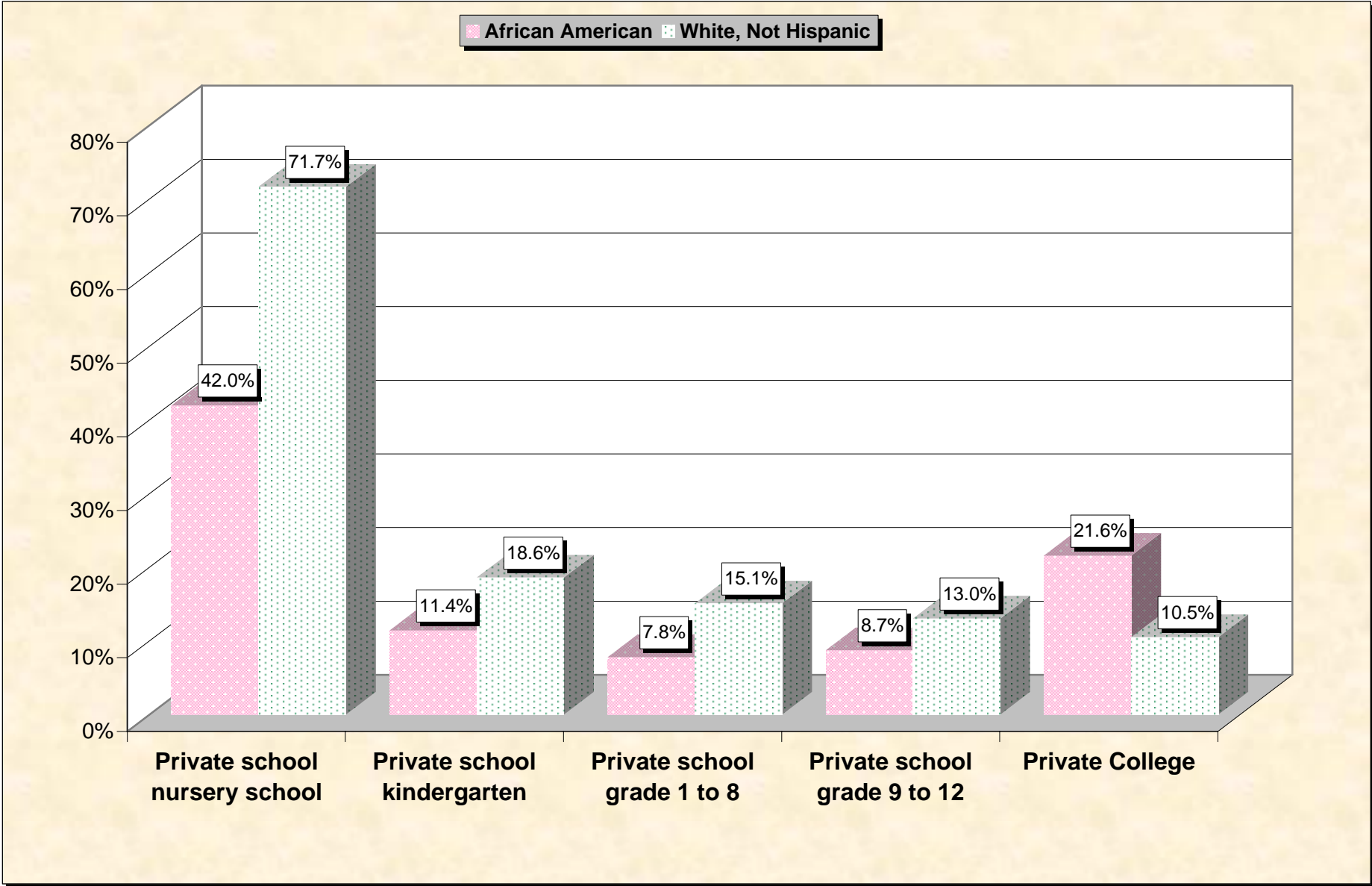

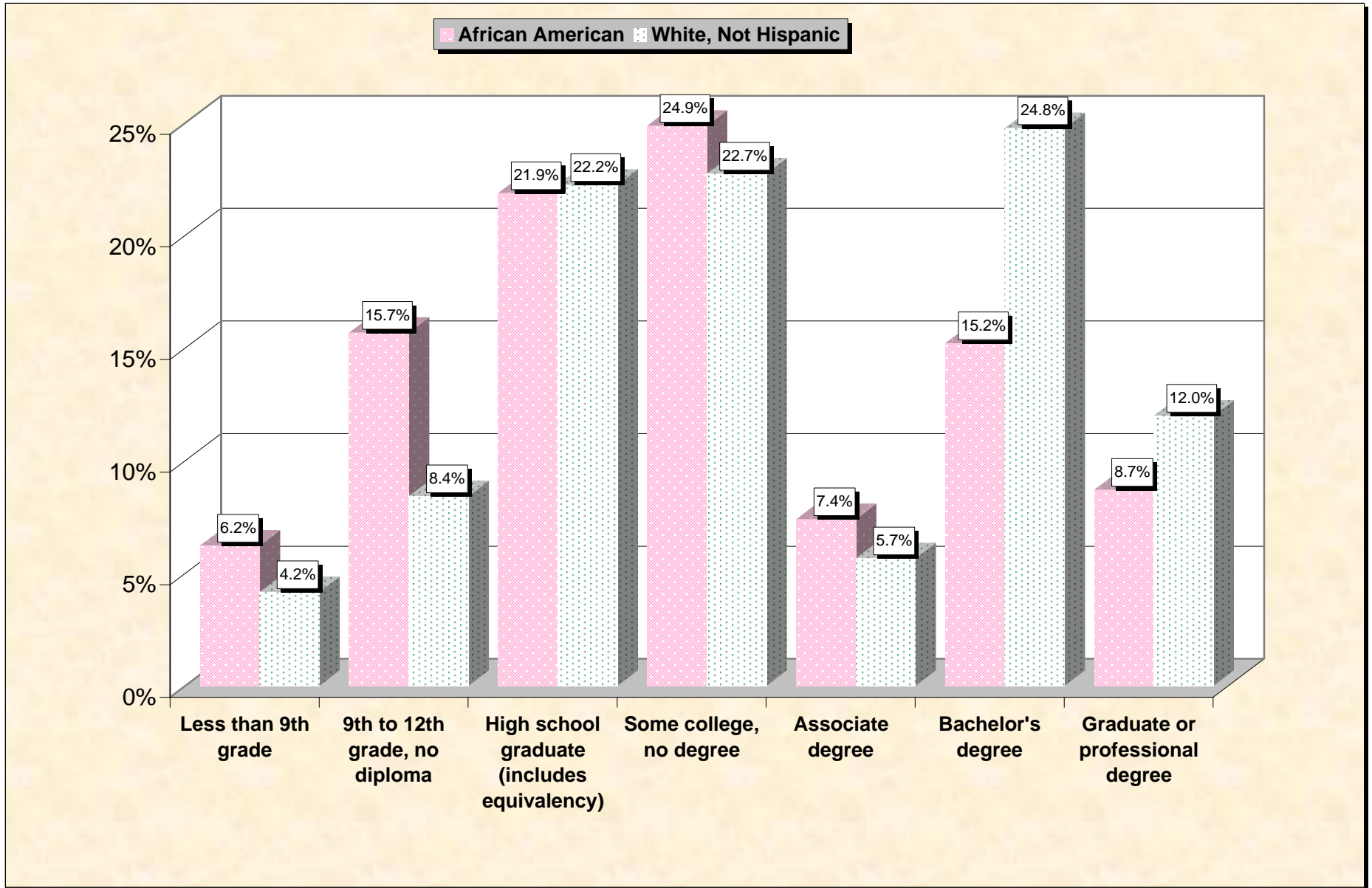
Chart 2 -- Private School Enrollment (3 years and over)

Madison County, Alabama



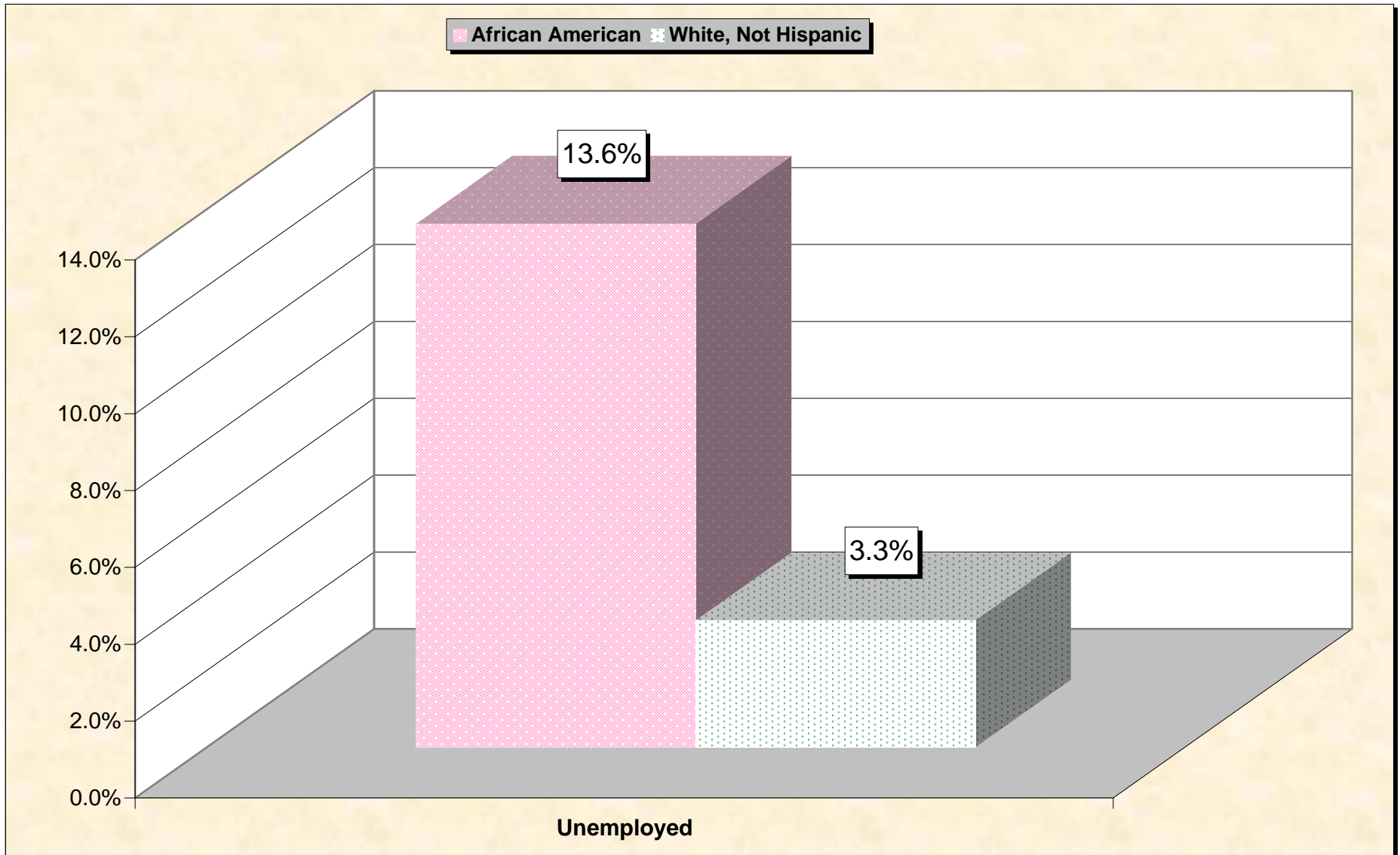

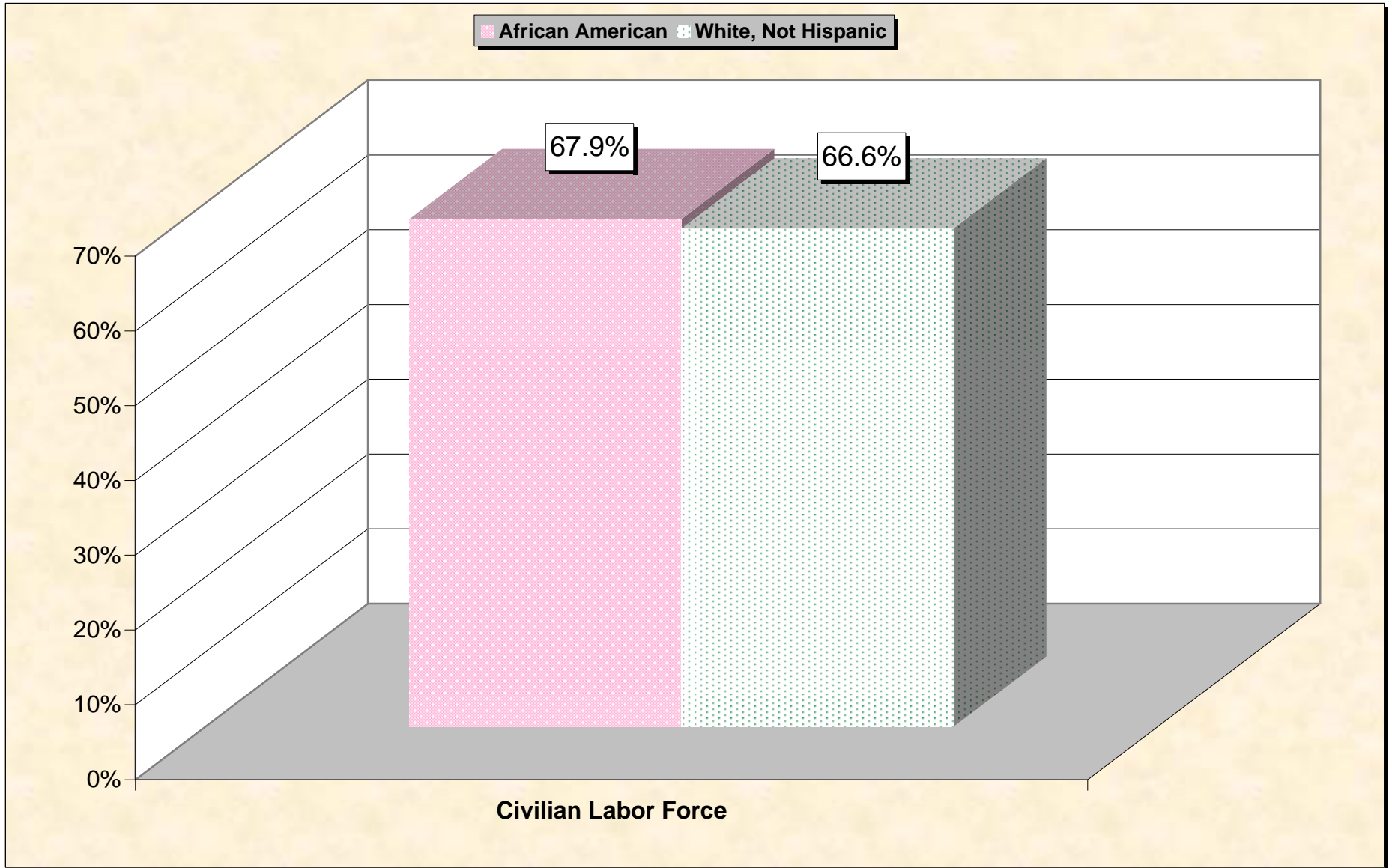
Chart 4 -- Unemployment Rate (Civilian Labor Force) Madison County, Alabama

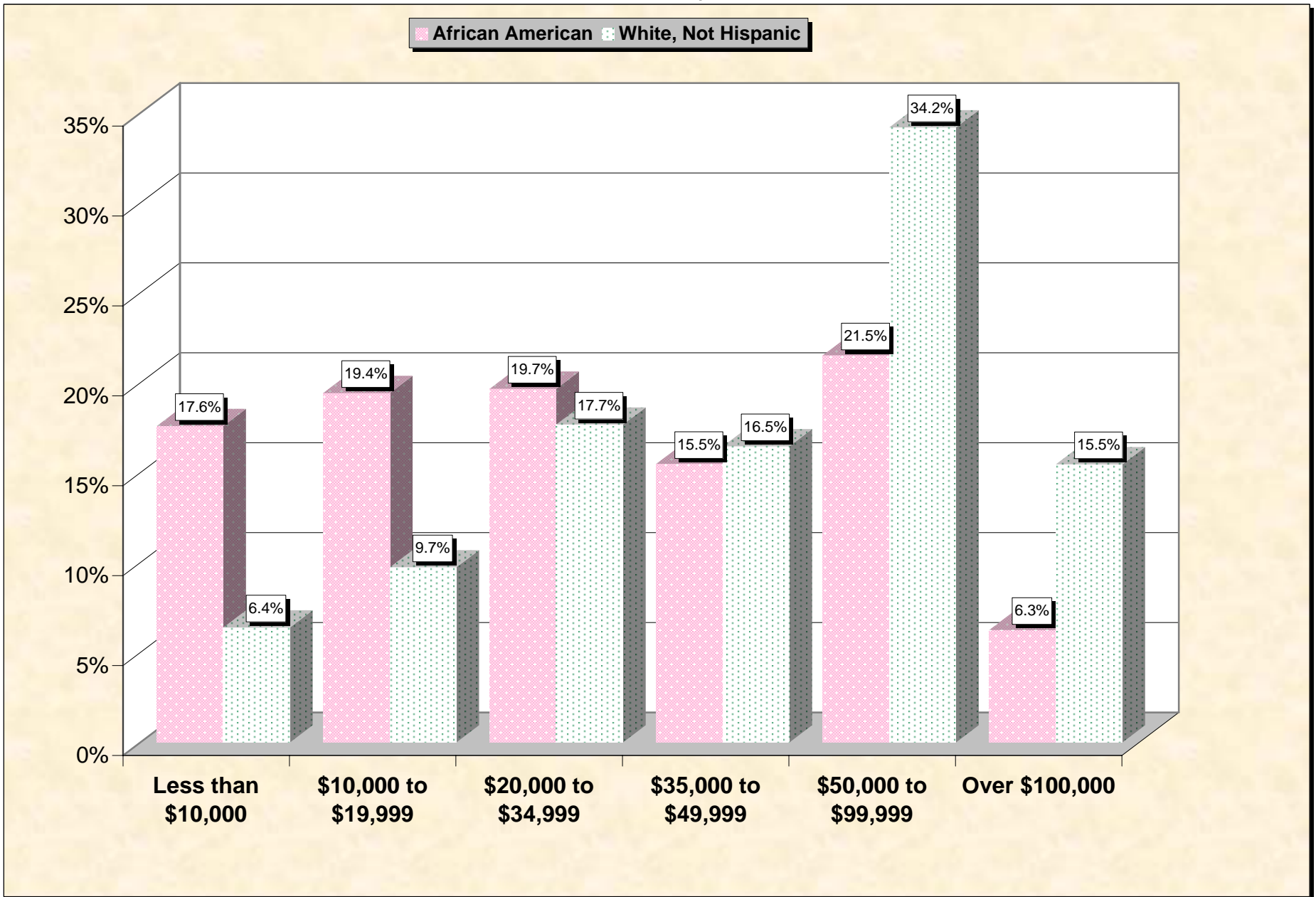
Chart 5 -- Labor Force Participation (Civilian Labor Force) Madison County, Alabama

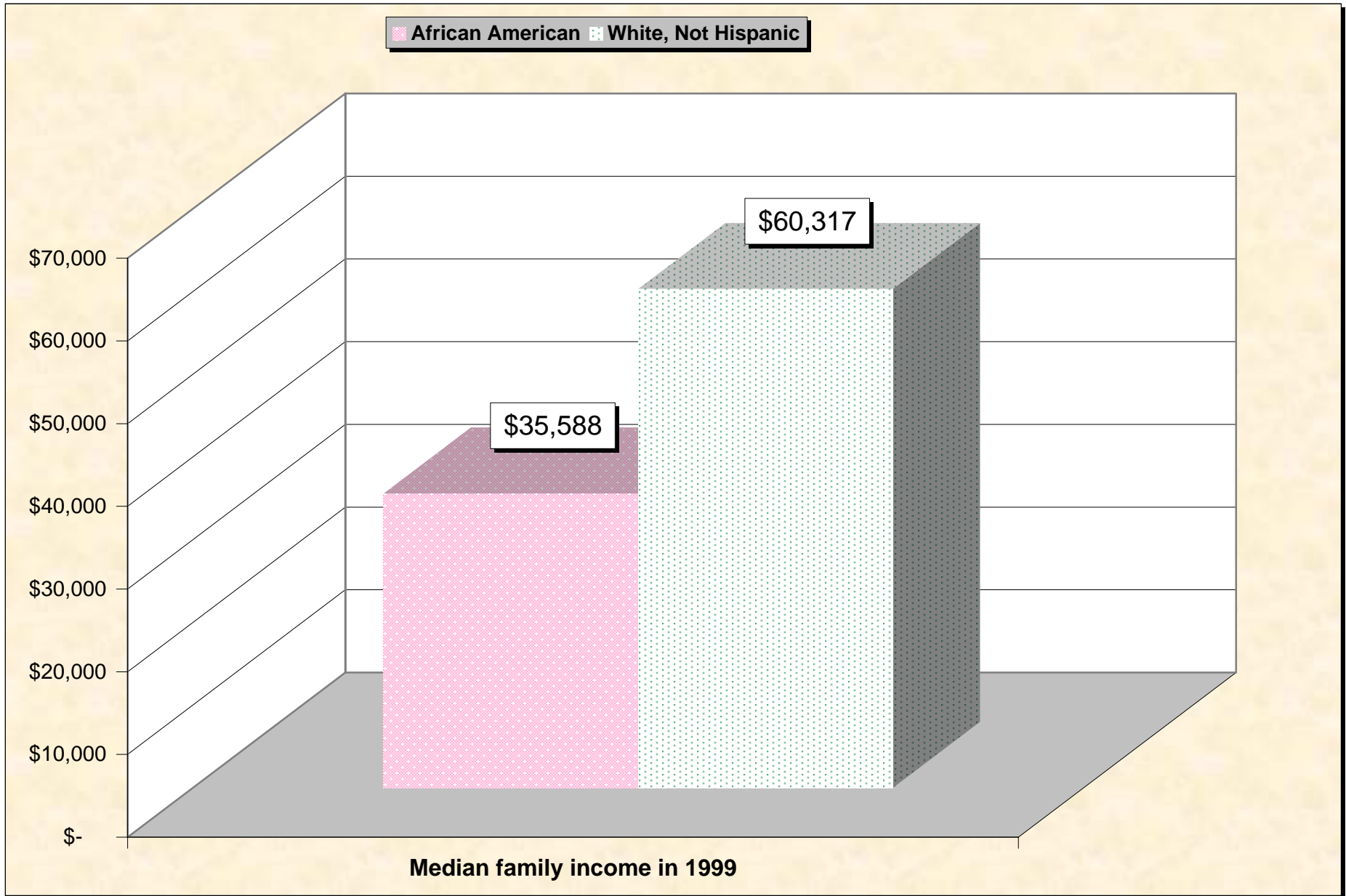
Chart 6 -- Household Income in 1999 Madison County, Alabama

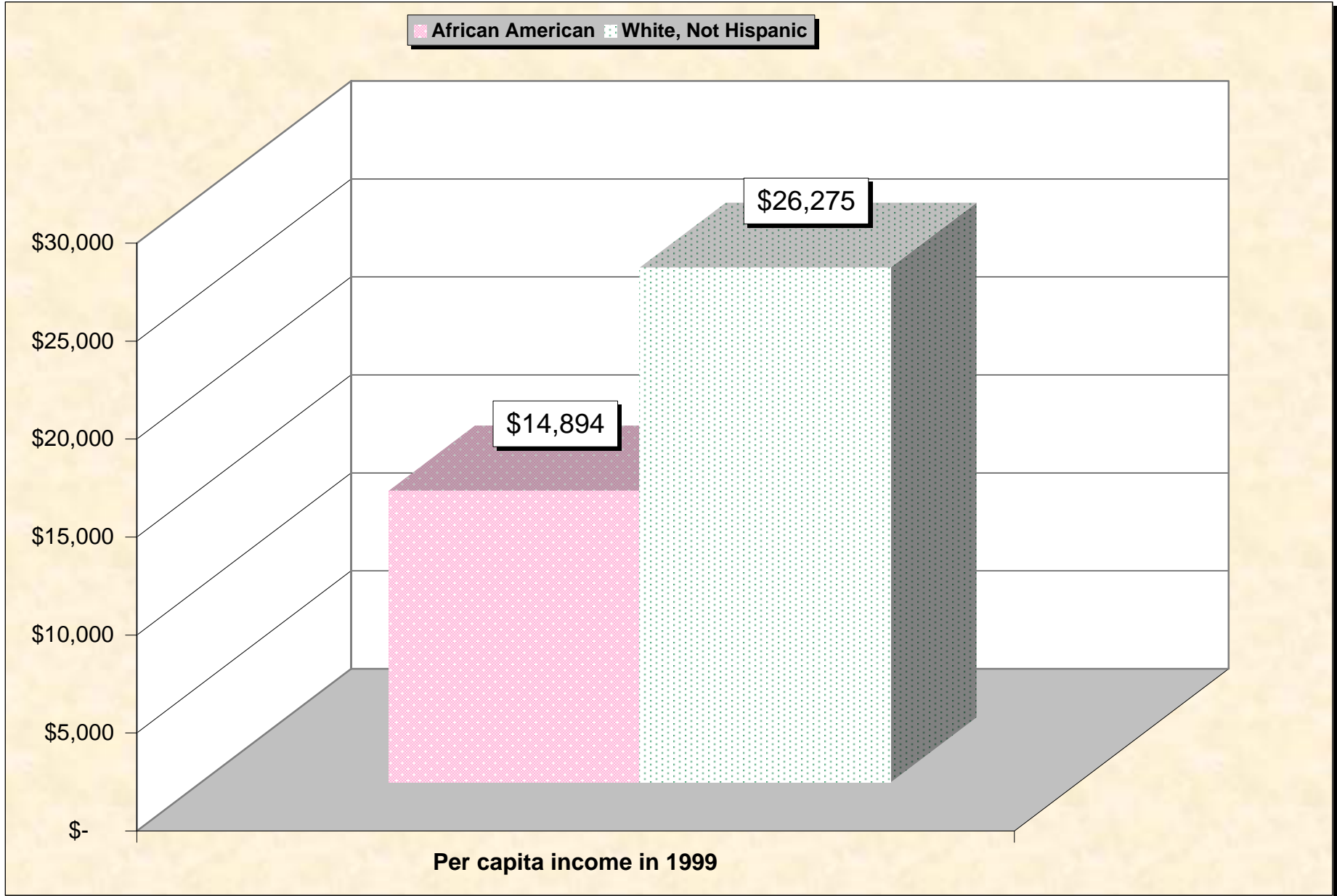
Chart 7 -- Median Family Income In 1999

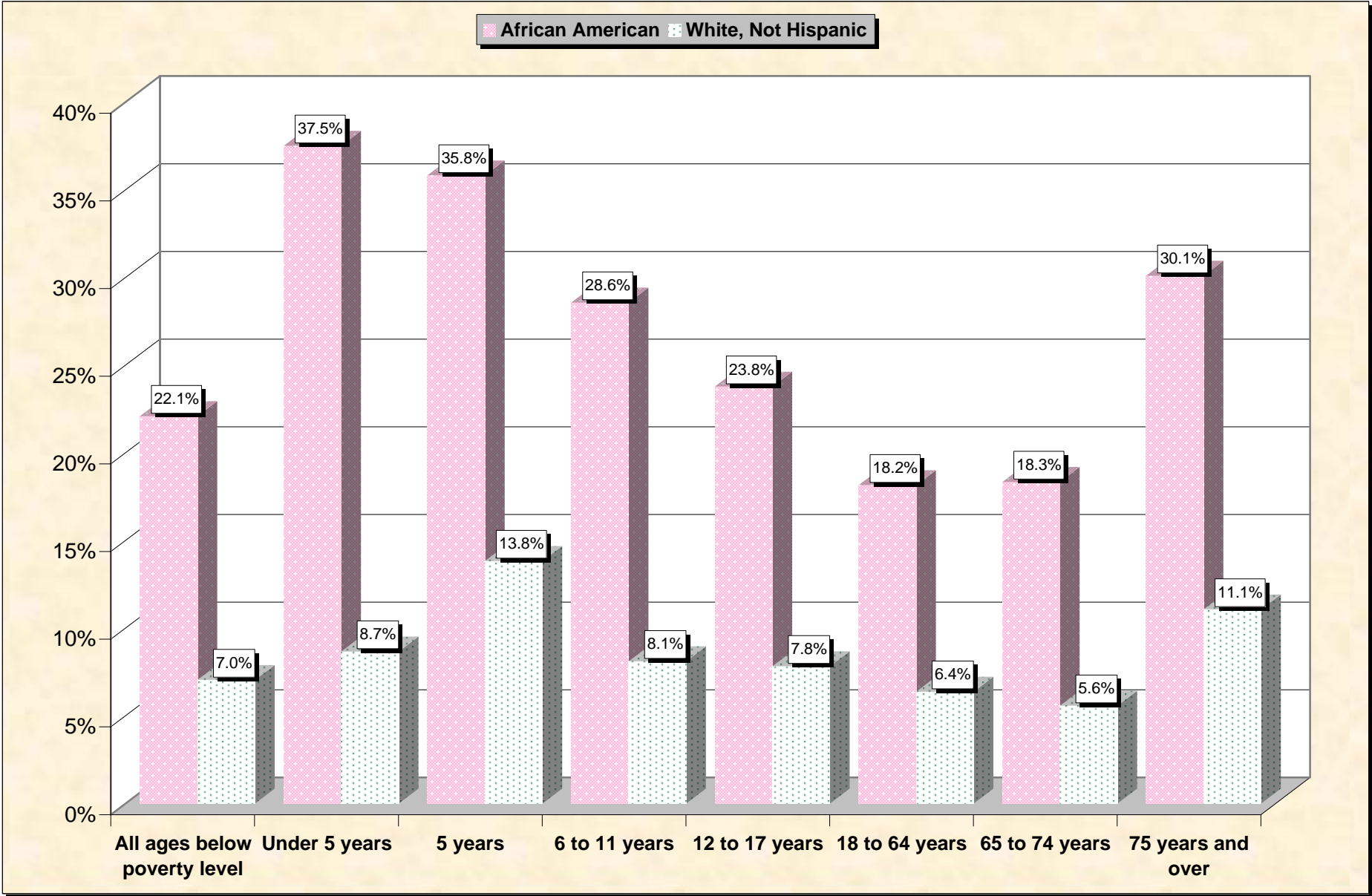

Chart 8 -- Per Capita Income In 1999 Madison County, Alabama



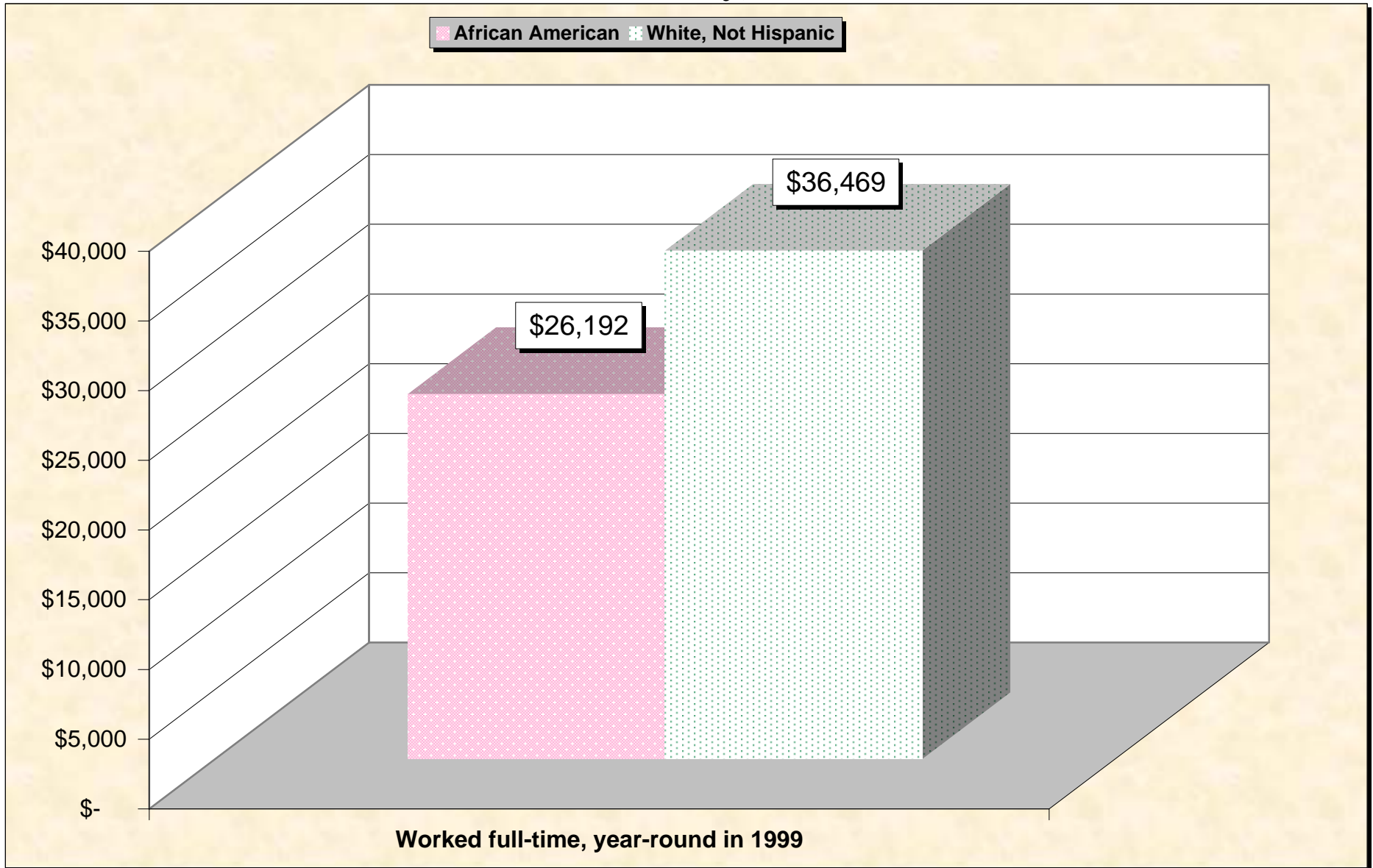

Chart 9 -- Income in 1999 Below Poverty Level by Age Madison County, Alabama



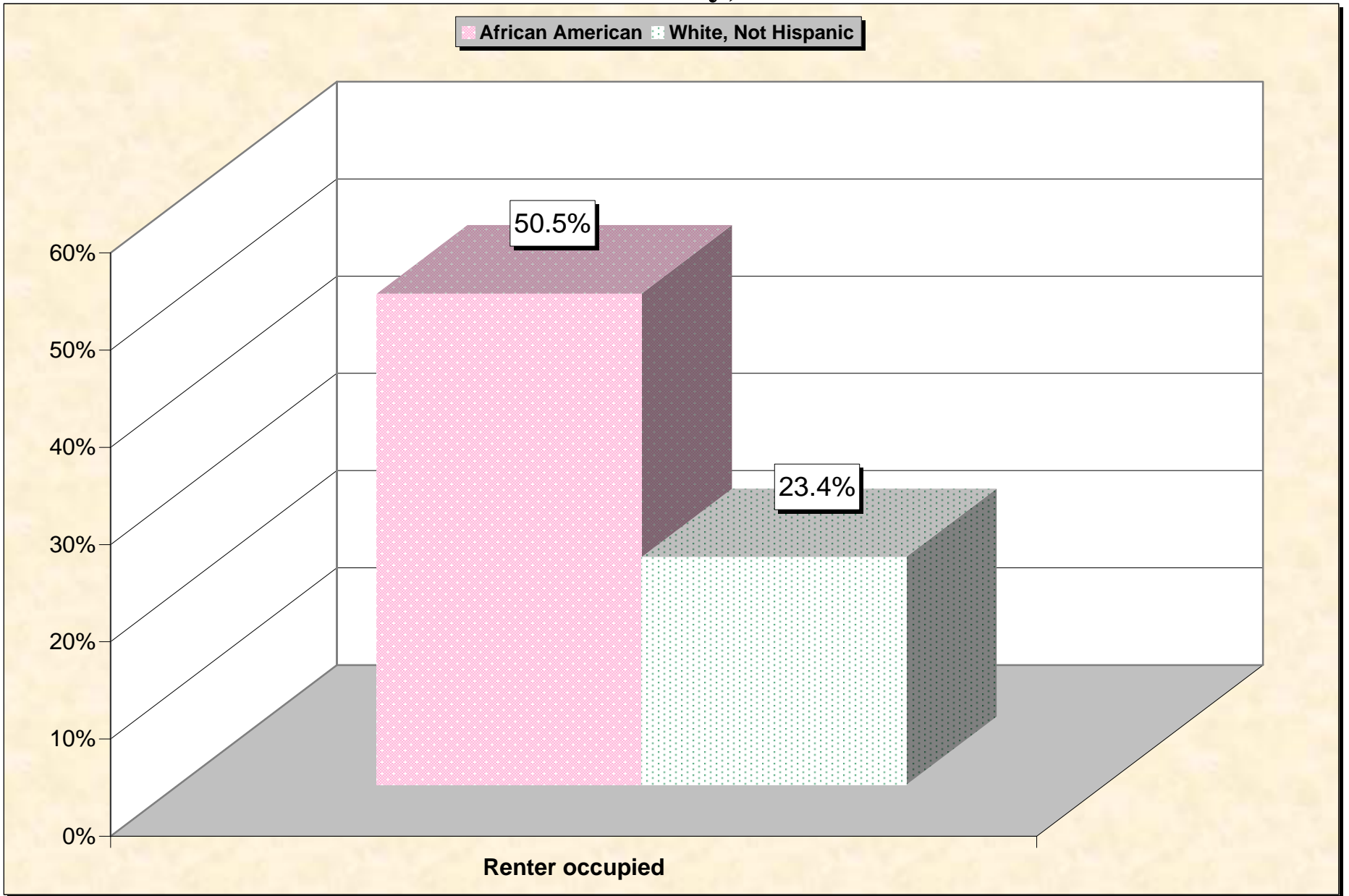

Chart 10 -- Median Earnings in 1999 Madison County, Alabama



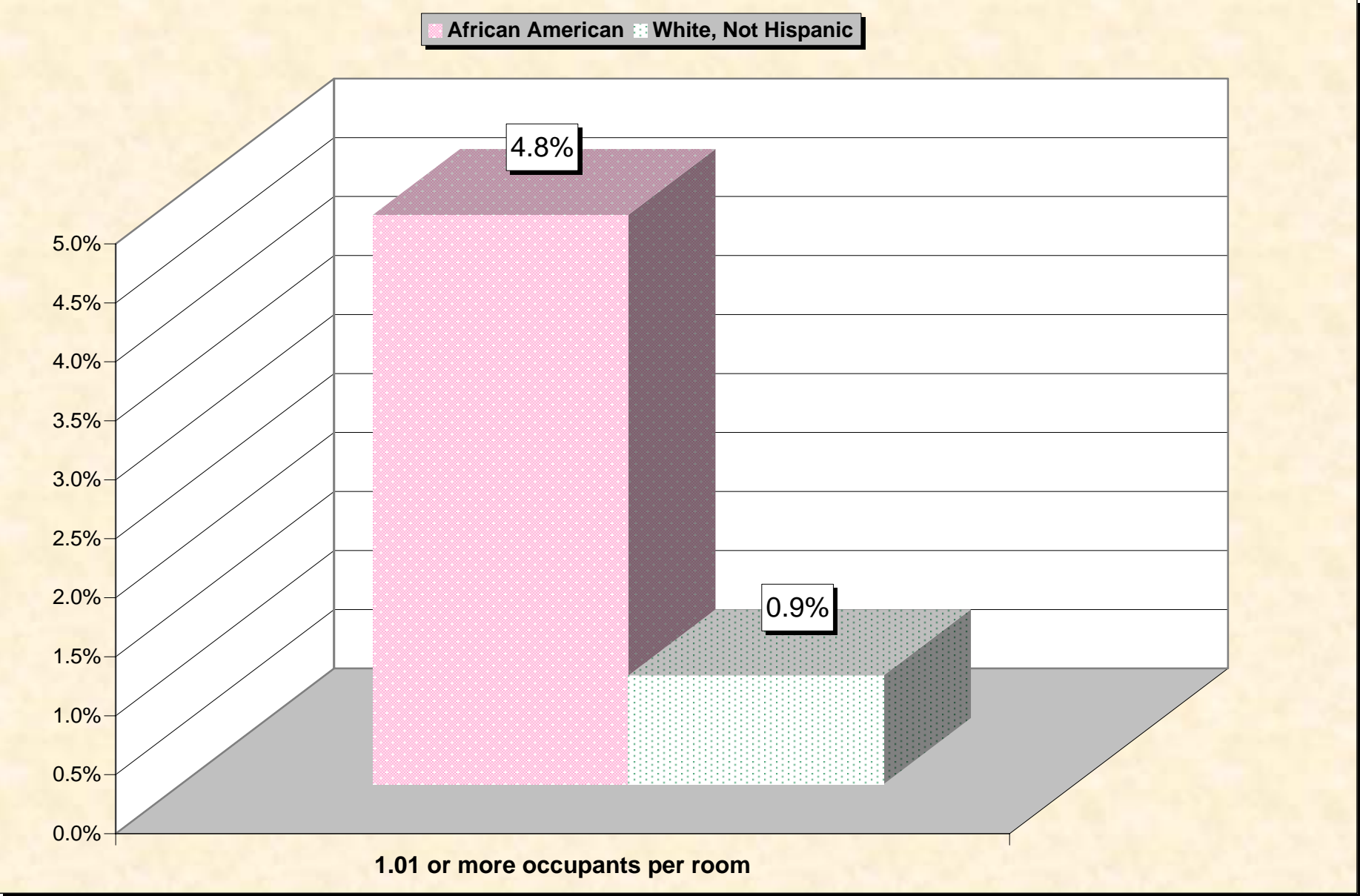

Chart 11 -- Renter-Occupied Housing Madison County, Alabama



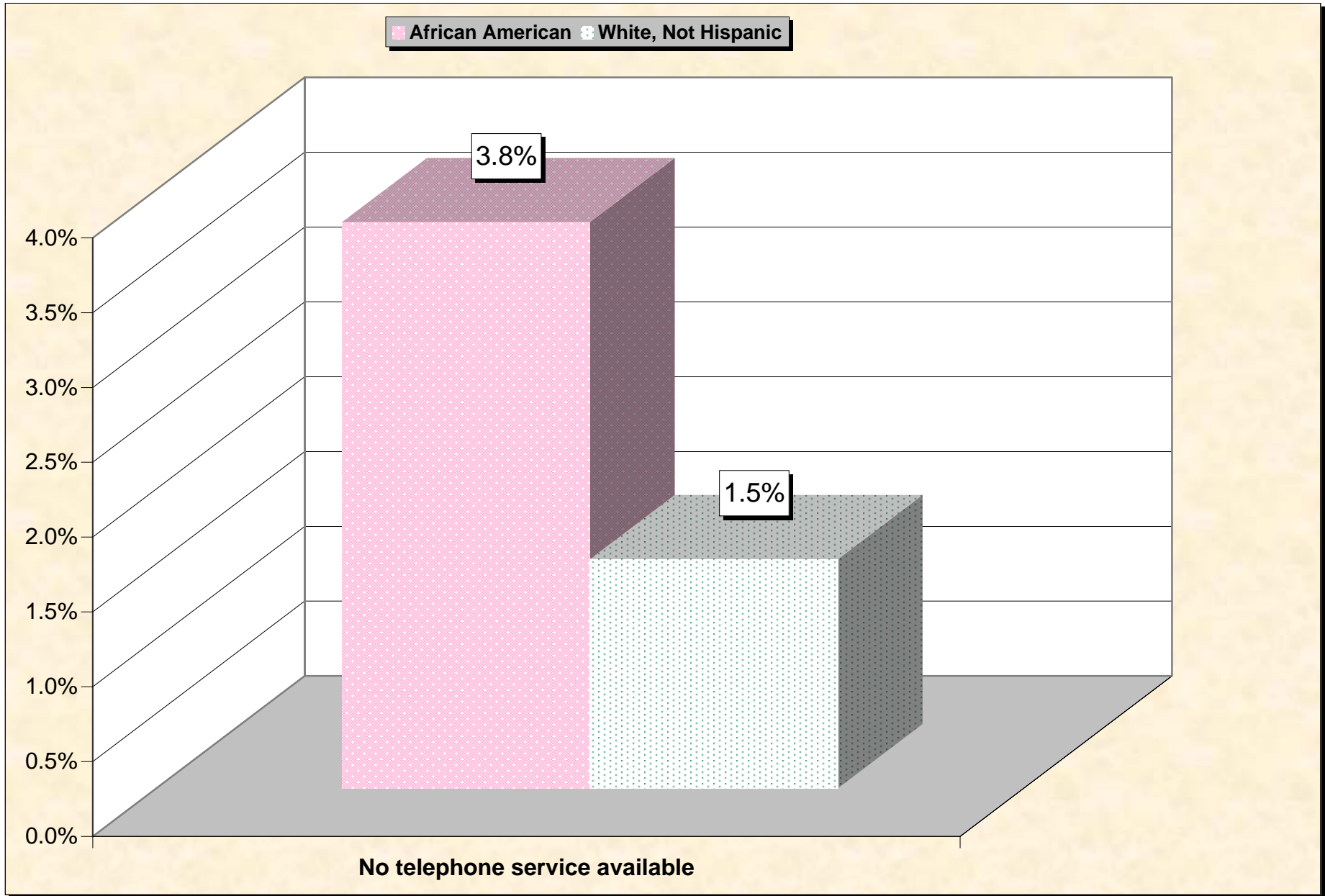

Chart 12 -- Occupants Per Room (Crowding) by Household Madison County, Alabama



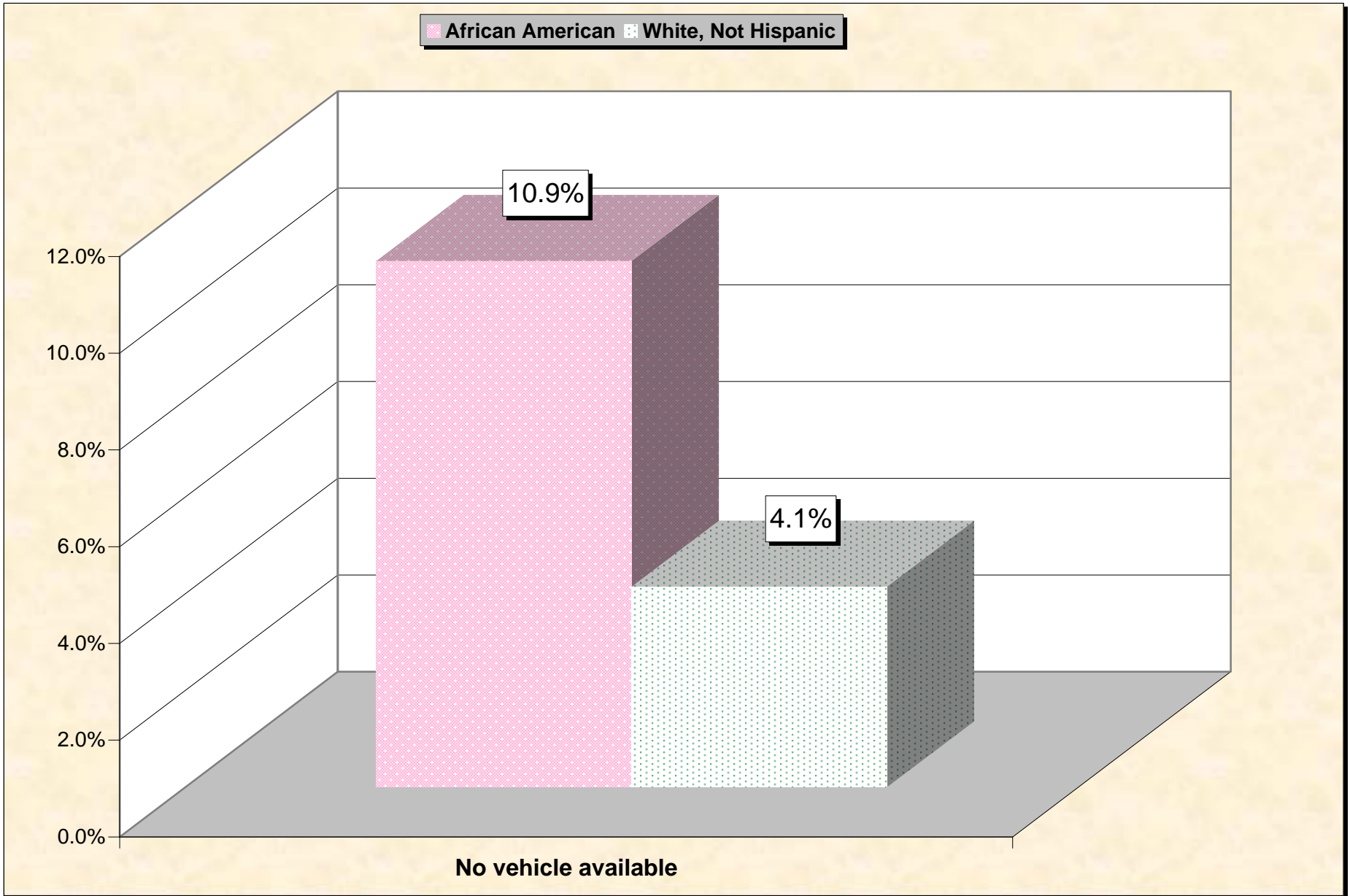

Chart 13 -- Lack of Telephone Service by Household Madison County, Alabama



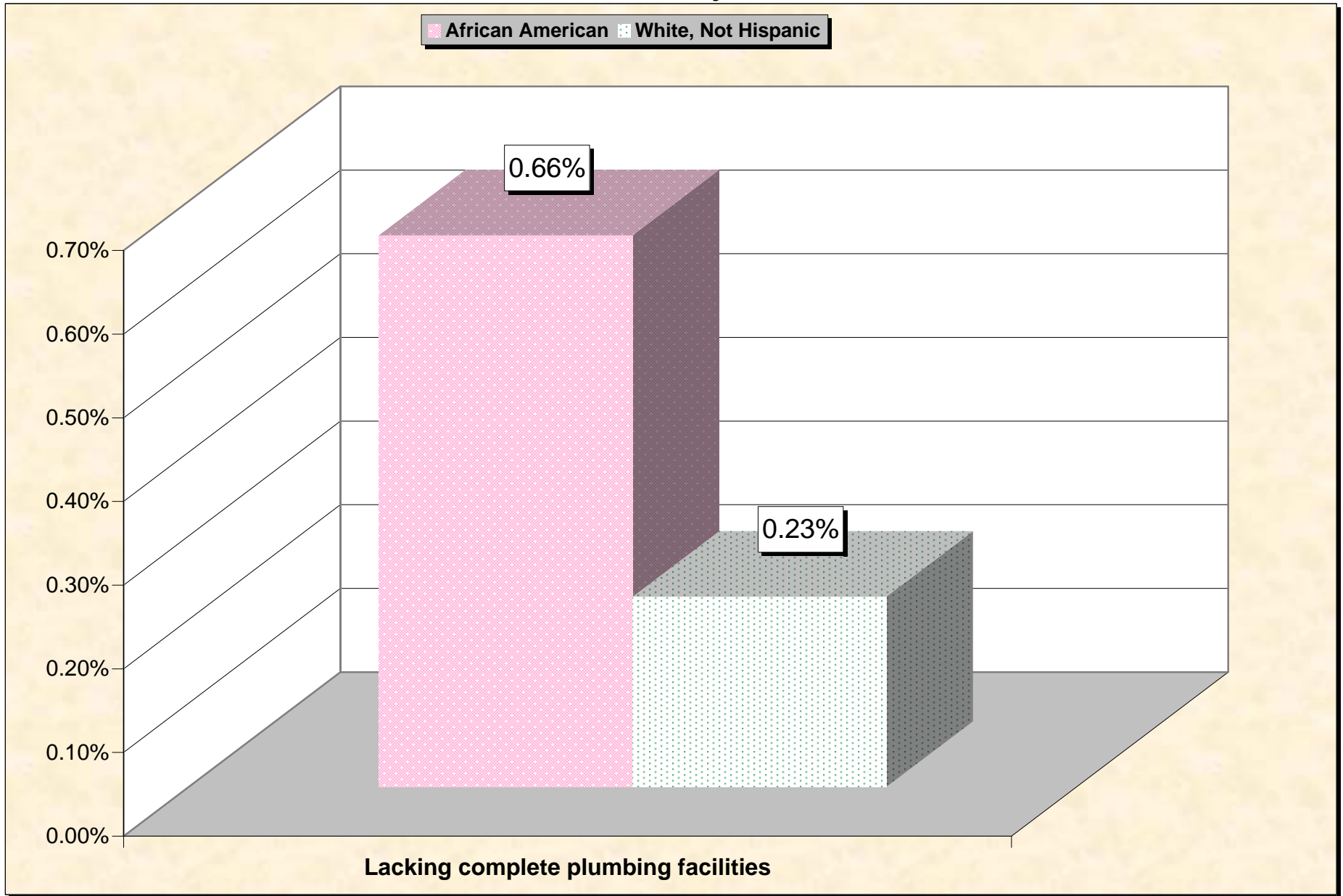

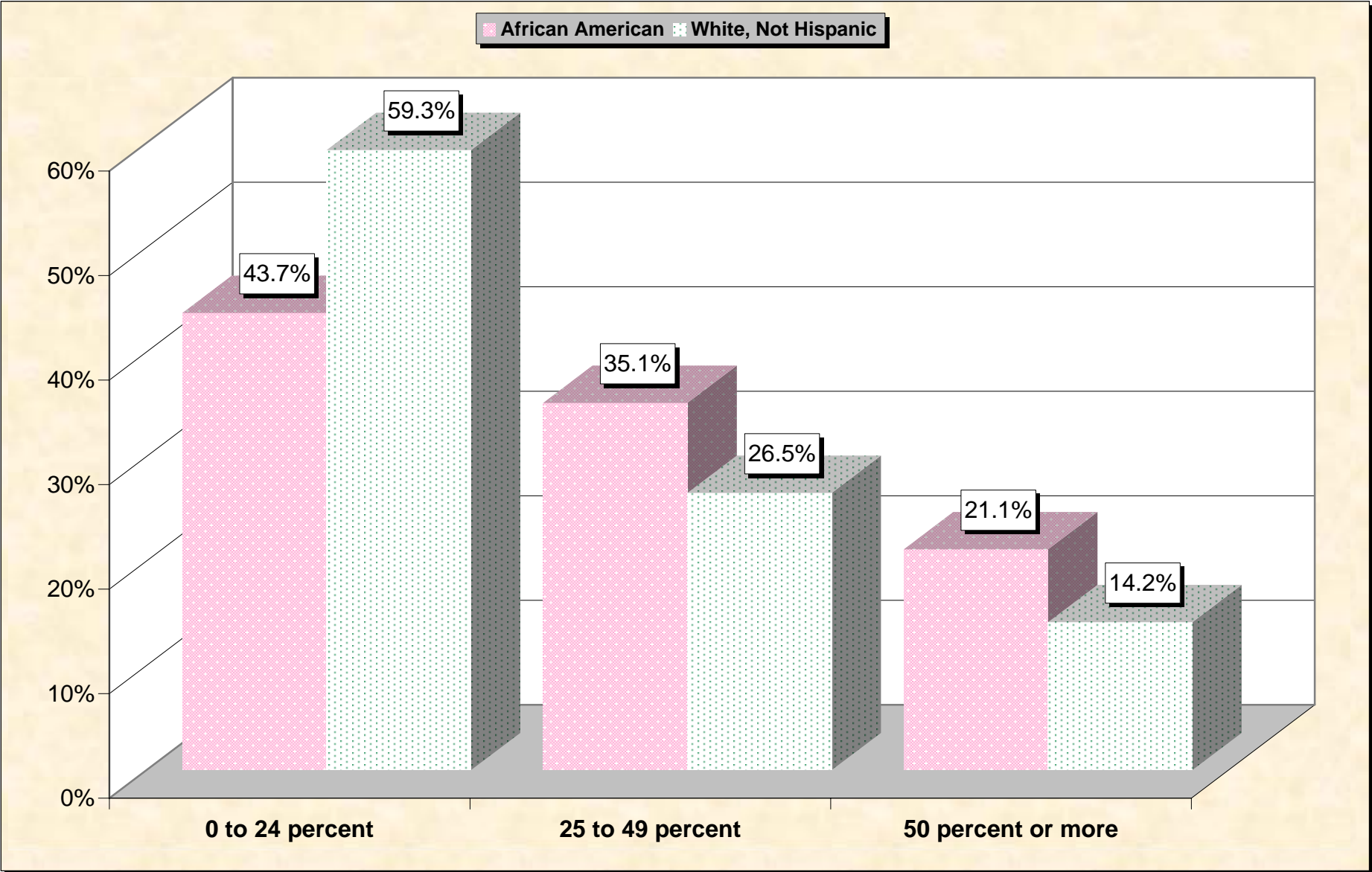
Chart 15 -- Lack of Plumbing By Household Madison County, Alabama

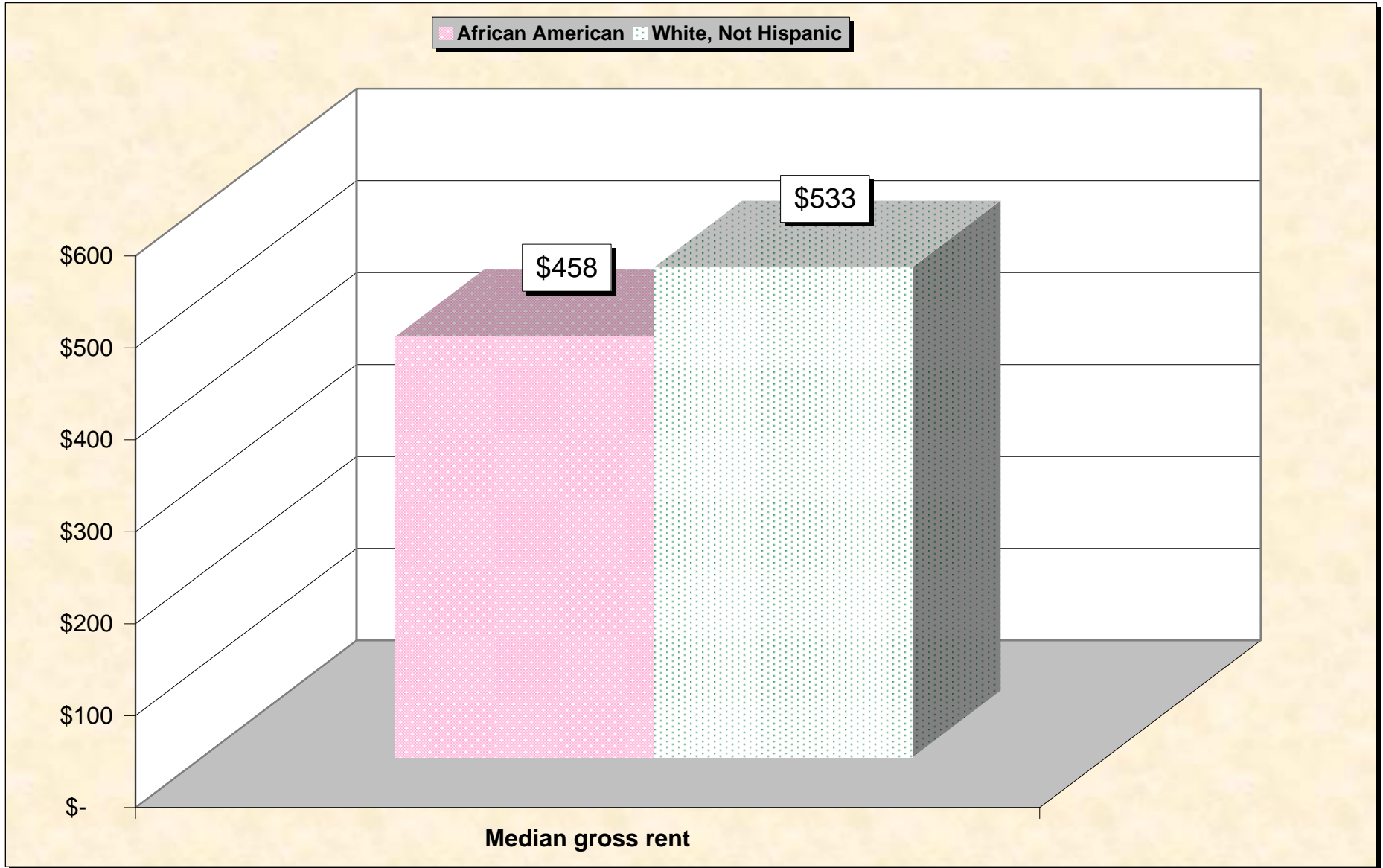
Chart 16 -- Gross Rent as a Percentage of Household Income in 1999

Madison County, Alabama



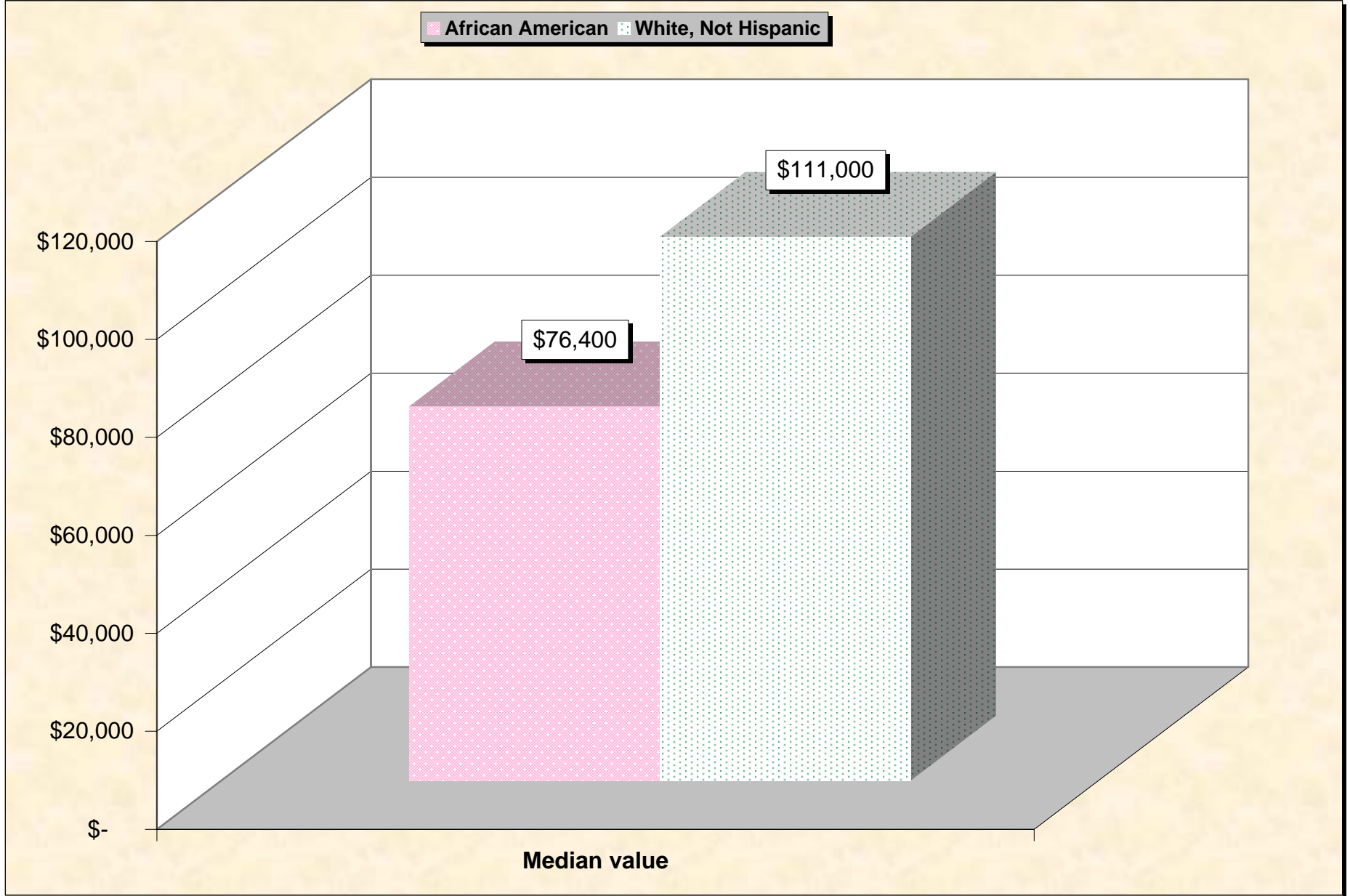
